TERMS & CONDITIONS OF SALE

1. STORAGE & RISK / LIABILITY / UNSOLD LOTS

All plant, machinery, equipment and other goods are entered for sale and placed on the sale ground entirely at the owner's risk. Halls Holdings Ltd (hereinafter referred to as Halls) accept no responsibility or liability for any loss, theft damage or deterioration, however caused, whether occurring before, during or after the sale, including whilst items are on the sale ground, in yards, buildings or parking areas. It is the responsibility of the owner to ensure that adequate insurance cover is in place at all times. If lots are unsold, vendors must collect their unsold lots as soon as possible after the sale. Halls reserve the right to charge for handling and storage at the rate of £20+ VAT, per week.

2. ROLE OF HALLS

Halls act solely as agents and intermediaries between the seller and the buyer and do not sell goods acting as Principal.

3. CONDITION OF LOTS

All machinery, plant and equipment must be presented for sale with any known faults or issues, whether visible or not, declared to Halls.

4. POWER TAKE OFF DRIVE SHAFTS

All PTO drive shafts must be securely attached to the respective implement or correctly labelled with the Lot number and placed in Halls main site office. It will be presumed that all PTO drive shafts are not available to purchasers unless a statement is given to the contrary at the time of the sale.

5. RESERVES

Reserve Prices for any lots must be submitted in writing on this entry form in the space provided. If a reserve is in place on any lot, it is the vendors sole responsibility to ensure if the lot has been sold or not on the day of the sale and remove it as it remains the responsibility of the vendor.

6. TITLE, OWNERSHIP & FINANCE

The vendor warrants that all lots entered are the vendors absolute property, free from finance or encumbrance, unless declared in writing on this entry form. The vendor shall be solely responsible for discharging any finance, and Halls accept no liability in respect of title.

7. SUITABILITY

Halls reserve the right to refuse or withdraw any lot from sale at their absolute discretion, without liability.

8. PAYMENT FOR SOLD LOTS

Payment will be made 15 working days from the day of the sale. Our preferred payment method is by bank transfer, please provide your bank details. Please inform us should your bank details change in the future. If no bank details are held, payment will be made via cheque.

9. VAT

Please indicate clearly whether your items are subject to VAT. If so please provide us with your valid VAT registration number to enable payment to be made to you. VAT will be charged at the standard rate applicable at the time of the sale, currently 20% on all applicable items.

10. SAFETY & COMPLIANCE

No Lot is sold as complying with PUWER, CE or UKCA marking, or electrical safety regulations unless expressly stated in writing at the time of sale.

11. POCA

Under the Proceeds of Crime Act 2002, we cannot accept single or linked cash payments over 10,000 euros. For any larger payments, please use bank transfer, debit card, or cheque. Where payment is made by cheque, goods may not be removed from the site until receipt of cleared payment. All Halls Livestock and Machinery Auction customers must complete IDV checks before their first purchase. Please provide original copies of the following to be copied and held securely on file:

- One form of photo ID (passport, UK driving licence, etc)
- One document confirming your address (utility bill, bank statement, council tax bill, firearm/shotgun certificate).

Halls reserve the right to carry out online theft and asset verification checks as part of our standard due diligence and customer onboarding procedures. This may include searches via recognised industry databases, including The Equipment Register.
